### Bringing a Kinder World to Life Art Contest Official Rules

In order to enter this contest, participants and, if they are under 18 years of age, their parents/legal guardians must agree to these Official Rules. If you are under 18, you may not enter this contest or agree to these rules without a parent or guardian's consent. By entering this contest, participants, and parents/legal guardians on their behalf, agree to abide by these Official Rules.

#### CONTEST SPONSOR:

The “Bringing a Kinder World to Life” Art Contest is sponsored by Phoenix Zones Initiative.

#### ELIGIBILITY:

This contest is open to people of all ages who reside in the US. Organizations are not eligible, either as an entity or through representation by an individual. In order to be eligible for a prize, the Entrant must provide complete and accurate information.

#### SUBMISSIONS:

- Your submission must address the theme of “Bringing a Kinder World to Life.”
- Your submission must be your own original work and must not contain any elements that are protected by someone else’s copyright, trademark, or otherwise subject to third-party intellectual property or proprietary rights, including privacy and publicity rights.
- Your submission must not depict or involve the exploitation or harm of another being.
- Your submission must be submitted in digital form (physical artwork cannot be accepted).

## Official Rules

Submissions due November 1, 2021

- Your submission must not contain obscenity, explicit sexual material, nudity, profanity, graphic violence, calls or incitement to violence, commercial solicitation or commercial promotion. Submissions must conform to local law and must not contain content or images that could be considered abusive, inflammatory, denigrating, or disrespectful to any of the Contest Sponsors, or to any groups, individuals or institutions.
- In the event of any question or difference of views regarding compliance with, interpretation, or application of these content requirements or other provisions of these Official Contest Rules, Contest Sponsors reserve the exclusive right to resolve such questions or differences of views at their sole discretion.
- By submitting artwork to the contest, the Entrant and/or a parent/legal guardian affirm that they have obtained written consent from all individuals whose image or likeness appears in the artwork, and that they have obtained the necessary rights, licenses, consents, and permissions to use all material such as images, text and other content in the submission. The Entrant and/or a parent/legal guardian further affirm that they are prepared to provide reliable documentation of any and all such consents, licenses, etc., upon request. Failure to obtain such rights, license consents, and permissions may result in the disqualification of the submission at the Contest Sponsors' sole and absolute discretion.

### HOW TO ENTER:

Entries may be submitted between Monday, September 27, 2021, and Monday, November 1, 2021.

2. All submissions must follow the submission guidelines outlined above.
3. By participating in the Contest, each Entrant and any Entrant's parent or legal guardian fully and unconditionally agrees to and accepts these Official Rules and the decisions of Phoenix Zones Initiative and of the judges, which are final and binding in all matters related to the Contest.

Submissions due November 1, 2021

### WINNERS:

Winners will be selected by a panel of judges. Any incomplete artwork or submission form will be disqualified. Winner(s) will be contacted via email at the email address they provided for registration. The inability of Contest Sponsors to contact a potential winner may result in disqualification and/or selection of an alternate winner from among all remaining eligible submissions.

All submissions will be judged based on

- relevance to the theme
- creativity
- emotional impact
- quality of the work

Winners in each category (Adult/Youth) will receive the following prizes\*:

1st place: \$50 gift card

2nd place: \$25 gift card

3rd place: \$10 gift card

Finalists and/or winners grant Contest Sponsors an irrevocable, worldwide, non-exclusive, royalty-free, fully sub-licensable and transferable license to use, reproduce, distribute, prepare derivative works of, and/or display the submission in any media formats and through any media channels in perpetuity.

### RELEASE:

- Contest Sponsors do not endorse any submissions or messages expressed therein, and Contest Sponsors expressly disclaim any and all liability in connection with the submitted entries, including disputes between collaborators related to a submission.
